## Background

Mr. Charles V. Campisi is the Senior Vice President of Cyber Diligence, Inc. He is in charge of the firm's Law Enforcement Consulting Services Division. His division provides consulting services to sovereign nations, government organizations, law enforcement agencies and legal communities on policing-related matters. Mr. Campisi leads a team of former law enforcement professionals who collectively possess over 100 years of policing and investigative experience.

Mr. Charles Campisi has served in the New York Police Department since October of 1973, filling a multitude of roles in the organization. Standing out among the positions he has held are a variety of police operational, investigative, administrative and managerial assignments. Since July of 1996, Mr. Campisi has been the head of the largest and oldest internal affairs investigative entity in the world. He was one of the architects of the NYPD Internal Affairs Bureau at its inception and has served as the Bureau Chief for over seventeen years. Mr. Campisi is perhaps the most experienced professional in corruption prevention and internal investigations in the world.

Serving under three mayors and four police commissioners as a three-star bureau chief, Mr. Campisi has served as a member of Interpol's Expert Group on Corruption and on the International Association of Chiefs of Police Internal Affairs Advisory Committee. Mr. Campisi holds a Bachelor of Arts degree in psychology, a Master of Arts degree in criminal justice, and is currently on leave from his doctorate degree in criminal justice at John Jay College. He is also a graduate of the FBI National Academy, Boston University Law Enforcement Trainers Institute, Northwestern University Traffic Institute, Columbia University Police Management Institute and the John F. Kennedy School of Government at Harvard University.

Mr. Campisi has also served as the Commissioner of Correction, Chief Administrative Officer, Nassau County Sheriff's Department, New York from 2014 to 2018. Among other functions, he was in charge of internal investigations and inmate grievances.

On the international stage, Mr Campisi, as a member of numerous assistance teams sponsored by the United States Department of State, has worked with and advised foreign governments in establishing and strengthening internal controls. In addition, Mr. Campisi has consulted with legislative bodies, both locally and abroad, on the enactment of anti-corruption laws designed to help disclose corrupt practices, set ethical standards and guidelines, and provide criminal and civil penalties for violations.

International acknowledgement of Mr. Campisi's expertise in the field of policing and, more specifically, corruption prevention has allowed him to lecture on these topics at conferences in various countries including Indonesia, Armenia, Poland, Canada, Brazil, the Dominican Republic and Hungary, among others.
